

IN CASE OF DISCREPANCIES BETWEEN THE FRENCH TEXT AND THE ENGLISH
TRANSLATION, THE FRENCH TEXT SHALL PREVAIL

Dear Shareholder,

In preparation of the withdrawal of the United Kingdom from the European Union, Amundi Asset Management is taking the necessary steps to make its UK business fully regulated by the local regulator, the Financial Conduct Authority, and as such, the activities presently conducted by Amundi Asset Management London Branch will be transferred to Amundi (UK) Limited.

Consequently, the Board of Directors of Amundi Funds (the “**Fund**”), approved the decision of Amundi Luxembourg, acting as management company of the Fund, to appoint Amundi (UK) Limited, having its registered office at 41, Lothbury, London EC2R 7HF, United Kingdom, as investment manager of the sub-funds listed in the Annex 1 to this notice (the “**Sub-Funds**”) in place of Amundi Asset Management or its London Branch as from October 1, 2019.

Please note that these changes (i) will not affect any other characteristic of the Sub-Funds, including its level of fees and (ii) will not have any impact on the portfolio of the Sub-Funds.
