Le informamos que el **cierre de Magallanes Iberian Equity FI es ya efectivo.**

Como le anticipamos, al llegar el patrimonio de la estrategia Iberian a 500 Millones de €, hemos modificado los folletos de Magallanes Iberian Equity, FI y de la SICAV Magallanes Value Investors UCITS.
