**Re: Change of Fund and Share Class Names**

**(A) INTRODUCTION**

The Company has been established as an umbrella fund with segregated liability between sub-funds (each a “Fund”) and as an investment company pursuant to Part 24 of the Companies Act, 2014 and is authorised by the Central Bank as an undertaking for collective investment in transferable securities pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulation 2011, as amended.

The purpose of this letter is to inform you of certain changes relating to the Funds. The board of directors of the Company (the “**Board**”) has decided to change the names of certain Funds and the names of the Share classes of the Funds.

**(B) CHANGE OF NAME OF THE FUNDS**

It is proposed to change the name of certain Funds of the Company as described below, subject to the approval of the Central Bank:

Stryx America	Seilern America
Stryx Europa	Seilern Europa
Stryx World Growth Fund	Seilern World Growth Fund

The rationale for the change of name of the Funds is to align the name of the Funds with that of the Company and with that of the manager and promoter of the Company, Seilern Investment Management (Ireland) Limited (the “**Manager**”).

**(C) CHANGE OF NAME OF SHARE CLASSES**

It is also proposed to change the names of the Share classes of the Funds to align the names of the Share Classes with those of the Company and the Manager. It is proposed that the word “Stryx” in the Share class names be replaced with “Seilern”. Details of the new Share class names are set out below:

**(D) EFFECTIVE DATE**

The change in name of the Funds and Shares classes will take effect on or about 2 September 2019 which is the expected date of the noting of the revised Prospectus by the Central Bank (the “**Effective Date**”).

The Administrator, Brown Brothers Harriman Fund Administration Services (Ireland) Limited, will provide the Shareholders with written confirmations of ownership reflecting the new name of the relevant Share class.

(E) **REDEMPTION OF SHARES**

Shareholders who do not wish to remain invested in the Company following the implementation of any of these changes have the opportunity to redeem their Shares on any Dealing Day prior to the Effective Date by sending a completed redemption form to the Administrator by the redemption deadline for the relevant Fund for the relevant Dealing Day.

(F) **CONCLUSION**

The Directors of the Company consider that the proposed changes are in the best interests of the Shareholders of the Funds as a whole.
