Dear Shareholder.

1. Background

We wrote to you on 5 October 2018 outlining our proposals for a scheme of arrangement (the "**Share Class Merger**") under which holders of Euro class shares will be able to exchange their shares in the UK Company for shares in First State Global Umbrella Fund plc (the "**Irish Company**").

Holders of the Euro class shares have voted on the Share Class Merger and we are now writing to all shareholders to inform you of the results of the votes and to remind you of the actions you may wish to take.

2. Results of the voting

There are 18 sub-funds of the UK Company (and 55 share classes) which are in-scope for the Share Class Merger. Appendix 1 to this letter lists those sub-funds (and share classes) and the results of the voting for each.

31 of the 55 share classes have voted to implement the Share Class Merger. These classes are listed in Part A of Appendix 1 and will transfer to the Irish Company.

24 of the share classes in the UK Company did not pass the necessary resolution. These classes are listed in Part B of Appendix 1 and will not transfer to the Irish Company but will instead remain part of the UK Company (the "Non-transferring Euro Shares"). You should, therefore, not switch into Non-transferring Euro Shares with the intention of transferring to the Irish Company.


3. Do I need to take any action?

If you are an investor in one of the 18 in-scope funds listed in Appendix 1, whether you need to take any action will depend on the currency of the shares you hold and whether you wish to transfer to a fund in the Irish Company. The chart below sets out what action you may need to take and when.

Note that if you hold Non-transferring Euro Shares (i.e. the ones listed in Part B of Appendix 1) you do not need to take any action – these shares will remain in the UK Company as currently. If you still wish to transfer, you can switch into one of the transferring shareclasses.



ACTION REQUIRED IF YOU ARE INVESTED IN AN IN-SCOPE FUND



Note 1: If you hold Non-transferring Euro Shares (i.e. the ones listed in Part B of Appendix 1) you do not need to take any action if you do not want to transfer to a fund in the Irish Company – these shares will remain in the UK Company as currently.

Note 2: You should not switch into Non-transferring Euro Shares (i.e. the ones listed in Part B of Appendix 1) with the intention of transferring to the Irish Company.

Dependent on the outcome of Brexit negotiations, non-UK, European resident investors may be unable to make further investments into the UK Company after Brexit and so may wish to consider transferring to the Irish Company. Shareholders can of course redeem in the normal way – please refer to Appendix 2 for the last dealing day to redeem Euro class shares listed in Part A of Appendix 1 prior to the Share Class Merger.

Important note: Both switches and participation in the Share Class Merger may have tax consequences for you depending on your tax residency and circumstances. The transaction and any tax costs of the Share Class Merger within the in-scope funds will be borne by transferring Euro shareholders. If you are in any doubt as to the action you should take, you should seek advice from an independent professional adviser and you should seek your own independent tax advice.

4. Personal data

The UK Company collects and processes your personal data as set out in the privacy notice issued to you in February 2018 which is also available on our website at www.firststateinvestments.com/Brexit.

Personal data of Euro class shareholders will be disclosed to the Irish Company and its service providers (including the Irish Company's depositary and/or its administrator) in order to allow for know your client ("KYC") checks to be performed in advance (including in respect of shareholders in the UK Company who may not transfer to the Irish Company) and/or following completion of the Share Class Merger, and to the extent that this is necessary so that the Irish Company can issue the new shares under the Share Class Merger. The Irish Company depositary and/or its administrator will destroy any data which relates to shareholders in the UK Company who do not transfer to the Irish Company following completion of the Share Class Merger. The UK Company is entitled to disclose your personal data in this way because:

 the use of your personal data as described is necessary for our and/or the Irish Company's legitimate business interests; and/or



 the UK Company and/or the Irish Company has a legal and regulatory obligation relating to KYC confirmations that have to be fulfilled.

You have a number of rights in relation to the personal data that we hold about you as set out in the UK Company's privacy notice.
