A day (except Saturdays, Sundays and public holidays) on which banks in Dublin and London are open for normal banking business or such other day as may be specified.	A day (except Saturdays, Sundays and public holidays) on which banks in Dublin, London and Japan are open for normal banking business or such other day as may be specified.

Please note that, given that each Business Day is both a Dealing Day and a Valuation Day for the Sub-Fund, the amendment of Business Day above to include days on which banks in Japan are open for normal banking business, as well as in Dublin and London, in the definition of "Business Day" will also impact on the Dealing Days and Valuation Days of the Sub-Fund.

What action do you need to take?

You are not required to take any action.

Following this notice to Shareholders, the Directors intend to file an addendum with the Central Bank to implement these changes to the Man GLG Supplement. The changes are expected to take effect on or around 16 April 2019 or such later date as the Central Bank approves the addendum.
